

Terms of Use & Disclaimer

Welcome to the Last Mile Education Fund web sites (the “Sites”). The Sites include www.lastmile-ed.org, and any other web sites or services available through such sites owned or operated by Last Mile Education Fund. Please review the following terms and conditions concerning your use of the Sites. By accessing, using or downloading any information and/or materials from the Sites, you represent that you are at least 13 years of age and agree to follow and be bound by these terms of use (the “Terms of Use”). If you do not agree with these Terms of Use, please do not use the Sites.

These Terms of Use may be updated by Last Mile Education Fund from time to time without notice to you. In addition, when using particular Last Mile Education Fund services, you shall be subject to any posted guidelines or rules applicable to such services which may be posted from time to time. All such guidelines or rules are incorporated by reference into these Terms of Use. Last Mile Education Fund may also offer other services that are governed by different Terms of Service.

Privacy Policy

Your use of the Sites is subject to the Last Mile Education Fund [Privacy Policy](#), which contains disclosures relating to the collection and use of your personal information. You understand that through your use of the Service you consent to the collection and use (as set forth in the Privacy Policy) of this information, including the transfer of this information to the United States and/or other countries for storage, processing, and use by Last Mile Education Fund and its affiliates.

Registration

By using the Sites, you represent that you are at least 13 years of age. Where the Sites enable you to register for particular service offerings, you agree to: (a) provide true, accurate, current and complete information about yourself as prompted by the Site registration form (such information being the

“Registration Data”) and (b) we ask that you endeavor maintain and promptly update the Registration Data to keep it true, accurate, current and complete. If you provide any information that is untrue, inaccurate, not current or incomplete, or Last Mile Education Fund has reasonable grounds to suspect that such information is untrue, inaccurate, not current or incomplete, Last Mile Education Fund, its employees or designees shall have the right to suspend or terminate your account and refuse any and all current or future use of the Sites (or any portion thereof).

You will receive a password and account designation upon completing the registration process. You are responsible for maintaining the confidentiality of the passwords and accounts, and are fully responsible for all activities that occur under your passwords or accounts. Act
